No party shall hold out as an agent or representative of the other or create any liability for the other. The parties shall indemnify the other for breach of this clause.
- 2.3 Both parties shall maintain confidentially about any information, course material, plans, discussions, strategies or any material which shall be deemed to be confidential and marked accordingly. Any information, course material or the like in the public domain shall not be part of this commitment.

3. Limitation and Warranties:

- 3.1 Each party shall ensure that the other is not put to any liability for any act of the respective party.
- 3.2 Each party represents that they have the full power and authority to enter into this MoU in general.

4. General:

- 4.1 Both parties will designate a representative from its side, who will be the primary point of contact on behalf of the party.
- 4.2 Both parties shall not use the name of the other in any advertisement or make any public announcement without the prior written approval of the other.
- 4.3 Both the parties agree that **SBTECH** is not obliged on account of this MoU to recruit any fixed number of students from the **College**.

5. Termination:




