### MEMORANDUM OF UNDERSTANDING

MEMORANDUM OF UNDERSTANDING BETWEEN THE BONAM VENKATA CHALAMAYYA GROUP OF INSTITUTIONS (BVCG), BATLAPALEM, AMALAPURAM, KONASEEMA DISTRICT-533221 AND THE SOCIETY OF AGRICULTURE & RURAL DEVELOPMENT (SARD) KOVUURU, RAJAHMUNDRAY, EAST GODAVARI DISTRICT, AP

This agreement made this 11<sup>TH</sup> Sep 2021 between the Bonam Venkata Chalamayya Group of Institutions, a society registered "Society Registration Act" 1860,, here in after called "BVC Group" as the First part and the Society of Agriculture & Rural Development (SARD), Rajamahendravaram, East Godavari district, AP (second party).

1. This Memorandum of Understanding (MOU) sets for the terms and understanding between the BVC Group of Institutions, Amalapuram and the the Society of Agriculture & Rural Development (SARD), Rajamahendravaram, E.G.Dt., Andhra Pradesh to mutually share the research and development al activities of both organizations and to support BVC group in the execution of Science and Technology Innovation Hub/Community innovation and Incubation Center supporting by NITI AAYOG, Ministry of Electronics and Information Technology (MEitY, Ministry of Micro, Small and Medium Enterprises (MSME) etc.

#### Background

Formulate and enter into separate agreements, raise invoices as necessary in order to establish and operate specific projects arising from the collaboration and agreed between the parties from time to time. Both parties as per their discussions come to an agreement to support each other in the following aspects:

- (i) To support each other in the development of new technologies and innovations leading to the creation of new products up to the processing of Minimum viable Product.
- (ii) Sharing of necessary facilities available on either side to convert a raw material in to commercially viable product as per the norms of Industrial priorities. This agreement is like an Industrial partnership under Industry Institute Partnership (IIP).
- (iii) There is a need of volunteer's involvement while handling the community based funded projects by either party as when required, 2<sup>nd</sup> party (SARD) can arrange an MOU with 1<sup>st</sup> party (BVCG) as an NGO to support the requirements of community based projects.
- (iv) BVC Group is being handling several minor, major, mega and consultancy projects funded by Non-Government or Government funding agencies either for process development or product development useful in Aquaculture/ Agriculture / Horticulture. In this case 2<sup>nd</sup> party (SARD) may directly offer an MOU as per the norms of SARD to first party ie., BVC Group as FPO (Farmers Producing organization).
- (v) Either party may extend their support to the other party as when requires for the development of Research, innovation, creativity and motivations etc.

### Purpose

Explore ways and means to finance joint projects through special government Grants, and other funding sources by jointly applying for such funding and actively collaborating and investing on eligible research projects. Exchange information, faculty, staff and students in [both taught] and research programmers. Exchange information on research and teaching and learning materials relevant to the parties relevant educational and research programmers encourage members of staff and research students to undertake exchange visits and to take up fixed-terms assignments at the other party's establishment the terms and conditions for each visit to be discussed and agreed between the parties. Keep the arrangements between the parties under regular review in order to achieve the desired benefits of the Project for each party and to make any mutually agreed changes considered necessary and beneficial for the Project.

- (i) This MOU is for the purpose of improving the future activities and goals of research and Development and innovation through partnership. To plan, undertake, aid, promote and coordinate education, research, and its application in agriculture, agro forestry, animal husbandry, fisheries, home science and allied sciences.
- (ii) To act as a clearing house of research and general information relating t agriculture, animal husbandry, home science, allied sciences and fisheries through its publication and information system, and by instituting and promoting transfer of technology programmes.
- (iii) To provide undertake and promote consultancy services in the fields of education, research, training and dissemination of information in agriculture, agro forestry, animal husbandry, fisheries, home science and allied sciences.
- (iv) Conducting "on-farm testing " for identifying agricultural/ aquaculture / horticultural technologies for location specific sustainable land use systems.
- (v) Organize training to update the extension personnel with the advances in agricultural/ aquaculture / Horticultural technology on regular basis.
- (vi) Organize vocational training courses in agriculture/ horticulture/ aquaculture with allied vocations for the farmers/ scheduled caste/ scheduled tribes/ minorities/ local publics/ SHGs/ Womenfolk/ unskilled graduates etc., with emphasis on "learning by doing".
- (vii) Organize front-lines demonstrations to generate production data and feedback information.

The above goals will be accomplished by undertaking the following activities:

### Reporting

- (i) Making provision for imparting education in agriculture and allied sciences and humanities.
- (ii) Furthering the advancement of learning and prosecution of research in agriculture/ horticulture/ aquaculture and other allied sciences.
- (iii) Continuous support to undertake the extension, through appropriate media, of agriculture/ horticulture/ aquaculture and other allied sciences especially to the rural people of the State.

(iv) To support in making provision for the study of basic sciences and humanities, with a view to supporting other professional studies and thereby integrating such studies in the University curricula.

- Undertaking the integration of teaching, research and extension training with a view to promoting the productivity of agriculture.
- Conferring such degrees, diplomas, certificates and other academic distinctions as the University may deem fit.
- (vii) Joint contribution in design, develop and fabrication of machines, tools and accessories of the different equipment's using in the sectors of agriculture/ horticulture/ aquaculture for the benefit of local community, schedule caste/ schedule tribes or as per the targeted group of the funding agency.
- (viii) Such other purposes, not inconsistent with the provisions of this Act, which the State Government may, on application by University, by notification in the Official Gazette, specify in this behalf.

**Funding** 

This MOU is not for committing any financial agreement on either side of the organizations. Which organization is applying for funding is its own source and host the execution of entire project and the other party will support as per the availability of technology and expertise available on their side.

#### Duration

This MOU is at-will and may be modified by mutual consent of authorized officials from (list partners). This MOU shall become effective upon signature by the authorized officials from the (list partners) and will remain in effect until modified or terminated by any one of the partners by mutual consent. In the absence of mutual agreement by the authorized officials from (list partners) this MOU shall end on (14<sup>TH</sup> NOV 2024).
