And Bonam Venkata Chalamayya Engineering College, Odalarevu, Bonam Venkata Chalamayya Institute of Technology and Science, Batlapalem, and **BVC** College of Engineering, Palacharla, East Godavari District here after referred as ” **BVC**” represented by Sri Bonam Kanakayya, Secretary is of the OTHER PART

Whereas **MSME Tool Room, Hyderabad (CITD)** and **BVC**, shall be hereinafter jointly referred to as the "**Parties**" and singularly as a "**party**".

The Parties have decided to agree to establish industry-academic collaboration in the areas of mutual interest and in accordance with terms and conditions set forth in this Memorandum of Understanding (MoU), **MSME Tool Room, Hyderabad (CITD)** and **BVC** agree on following activities:

1. **MSME Tool Room, Hyderabad (CITD)**, will provide certification courses which includes Academic Projects and In plant training(Internship) at a concessional price of 10% to both the final year and third year students of **BVC**. To cater this, both the parties would mutually design the course and agree for the code of conduct. The number of students, who can be considered for such courses, would be as mutually decided by both the parties every year.
2. **MSME Tool Room, Hyderabad (CITD)** on request may extend assistance in placement of eligible students of **BVC**, who are trained at MSME Tool Room, Hyderabad(CITD).
3. **MSME Tool Room, Hyderabad (CITD)** will give full time access to the laboratories and library to the students of **BVC**, during their respective course of study.
4. **MSME Tool Room, Hyderabad (CITD)** will give Hostel accommodation at its campus to the students of **BVC**, during their respective course of study. The number of students who can be provided accommodation would be subjected to the availability of rooms.
5. **MSME Tool Room, Hyderabad (CITD)** will permit student visits for each of the class of **BVC**. To achieve this, both the parties would schedule the calendar of visits and agree on the code of conduct. The number of students who can be considered for such visits, would be as mutually decided by both the parties every year.

6. **BVC**, will send their students/Trainees to CITD for Courses in Certificate/Short-Term/Projects in every year without fail to maintain the spirit of this agreement between the both parties in technical aspects.
7. **BVC**, will give preference to the Diploma Holders from **MSME Tool Room, Hyderabad (CITD)**, in admission into Lateral Entry of B.Tech programs at **BVC**.
8. **BVC**, will give placement opportunity to the Diploma Holders from **MSME Tool Room, Hyderabad (CITD)** as laboratory technicians subjected to vacancy at **BVC**.
9. **BVC**, will give computer laboratories with atleast 500 terminals to **MSME Tool Room, Hyderabad (CITD)**, for any of its training programs or conduct of online examinations. To achieve this, both the parties would decide on the date depending upon the need.
10. **BVC**, will give access to indoor and outdoor sports and games for the purpose of conducting sports meet/ competitions to the students/ staff of **MSME Tool Room, Hyderabad (CITD)**. To achieve this, both the parties would mutually decide the dates of the event and coordinate accordingly.
11. **BVC**, will permit **MSME Tool Room, Hyderabad (CITD)** to hold official/ social gatherings of its student/staff in the capacities of 10/50/100/500/1000/2000 in its conference/meeting room/ seminar hall/ auditorium etc. at **BVC**. To achieve this, both the parties would mutually decide the dates of the event and coordinate accordingly.
12. **BVC**, will provide the Co author status to the staff of **MSME Tool Room, Hyderabad (CITD)**, in paper publications in case of joint R&D.
13. **BVC**, will invite **MSME Tool Room, Hyderabad (CITD)** to all kinds of technical activities being conducted at **BVC**.
14. **BVC**, will publish the notifications/ trainings calendar of **MSME Tool Room, Hyderabad (CITD)** in its quarterly newsletter.
15. **BVC**, will publish the notifications/happenings of **MSME Tool Room, Hyderabad (CITD)** in an exclusive notice board dedicated to **MSME Tool Room, Hyderabad (CITD)**.
16. Apart from the above mentioned points, both the parties may even any other initiations that strengthen Industry- Academia Interaction upon mutual consent.

Each Party shall appoint one nodal officer to periodically review and identify ways to strengthen cooperation between them. This MoU will take effect from the date it is signed by representatives of the parties. It will remain valid for five years and may be continued thereafter after suitable review and agreement. Either party may terminate this MoU mutually by giving written notice to the other party six months in advance. Upon termination, neither **MSME Tool Room, Hyderabad (CITD)** nor **BVC**, will be responsible for any losses, financial or otherwise, which the other party may suffer. However, **MSME Tool Room, Hyderabad (CITD)** and **BVC** will ensure that all activities in progress are allowed to be completed successfully.
